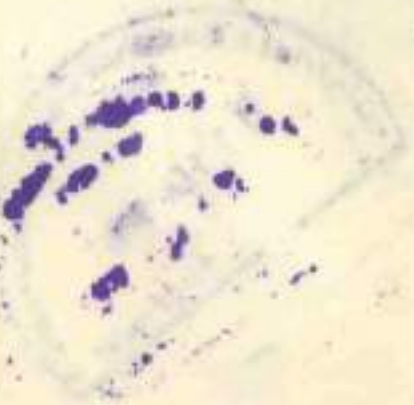

All the funds of the trust and the income arising from the investment of the trust fund shall be applied for the purpose of the trust in such a manner as the Board of trustees shall from time to time decide at the meeting in accordance with the objectives and purpose of the trust.

On dissolution the Trust properties the excess of assets over liabilities are to be transferred to Trust or Society having similar objects.

CONSTITUTION OF THE TRUST:

The number of trustees shall not be less than 3 and not more than 7 including the Managing Trustee. The Board of Trustees shall consist of the following persons.

1. Mr.S. Cletus Babu
2. Sr. Rose,
3. Mrs. Vimala Sathesh,
4. Ms. J.X. Ameli,
5. Mr. Ignatius Xavier
6. Fr. Peter Xavier
7. Mrs. Renuga Balakrishnan.

The trustees shall hold office for their respective lives. Any vacancy arising in the office of the trustees or Managing Trustee by reason of death, resignation or other valid reason be filled in by the surviving or remaining Trustees. If the number of trustees become less than three, the surviving or continuing trustees shall be entitled to appoint trustees or trustee as to bring the number of trustees to the minimum here in provided. The board of trustees shall.

from time to time determine the number of trustees for the Trust Board, but the total number of the trustees shall not exceed seven.

MANAGEMENT:

The day-to-day conduct and management of the affairs of the trust shall be carried on by Mr. Cletus Babu who shall be known as the managing trustee. Mrs. Vimala sathesh shall act as financial trustee and others as the members of the Trust.

POWERS AND DUTIES OF THE TRUSTEES:

The Trustees shall be in complete management of the affairs of the Trust and all institutions under the management of the Trust and may from time to time make Rules, By-laws for the conduct of their business and in particular to authorise one or more persons to act for the Trustees in respect of any transactions including purchase and disposal of properties.

Without prejudice to the abovesaid general powers and so as not in any way to limit or control these powers, the Trustees shall have powers,

to donate funds to institutions having the same object or objects and to Government welfare schemes.

to receive donations in any form.

to purchase or take on lease lands, buildings, equipments, materials and things, to erect and maintain building and other constructions and to sell, mortgage, dispose off or otherwise deal with any or all of the same as the Trustees may think fit and proper.

Cletus

to grant loans or borrow money as they may think fit and proper, control and manage the assets of the Trust and to execute, become party to sign, acknowledge, perfect and register all deeds, agreements, contracts, amounts, receipts and other documents and writings and to give effectual discharge on behalf of and against the Trust.

to sell, purchase, exchange and deal with any stocks, funds, shares, bonds, debentures, debenture stocks and other securities to draw, make, endorse, negotiate, execute and issue promissory notes bills of exchange, hundies, cheques, Government and other securities and other negotiable instruments.

to borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security, movable or immovable, as the Trustees may think fit and to secure payment thereof with interest by mortgage or by bond, promissory notes, bills, hundies and other negotiable securities or by issue of debentures.

to institute, conduct, defend, compound withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings claims or disputes by or against the Trust or Trustees or against its officers or employees concerning the affairs of the Trust and to sign and verify Vakilates, Pleints, written statement, execution of positions, affidavits, and other documents.

to appoint from time to time, full time and part time employees with such powers and duties and upon such terms as to duration of office, remuneration or otherwise and at any time to suspend dismiss or discharge any or such of them as the Trustees may think proper and necessary.

Chhina

to open and close accounts in the name of the trust in any scheduled bank, co-operative bank, post office or in any other state aided institution and to operate on such accounts and otherwise deal with the same.

to insure and keep insured if deemed expedient all or any of the buildings or assets of the Trust, to invest the surplus funds of the Trust in securities approved by law relating to Trusts in such manner as the Trustees may think fit and proper in the best interests of the Trust.

to delegate all or any of the powers, authorities and directions vested in the Trustees and generally to carry out such transactions as they consider expedient in the interest of the Trust and to make all such arrangements and do such acts and things on behalf of the Trust as may be usually necessary, desirable or expedient in the management of the affairs of the Trust or in carrying out its objectives.

MANAGING TRUSTEE:

The Managing Trustee shall be in sole charge of the entire functions of the Board of Trustees and shall be entitled to act for, and on behalf of, in the name of the Board of Trustees. Without prejudice to the foregoing General Authority granted to the Managing Trustee, all accounts of income from the Trust properties, operate on bank accounts in the name of the Trust, properties, incur expenditure for the administration of the Trust, collect funds and take all action and legal or other proceedings, before any court or Authority whatsoever.

Chakras

in the name of the Trust as may be decided by the Board of Trustees from time to time.

The Managing Trustee may delegate all or any of the foregoing powers to anyone or more of the Trustees and may revoke delegation of such authority at any time.

PROCEEDINGS OF THE TRUST:

- a. The Board of Trustees shall meet at least once in every four months, often if necessary on the requisition of the trustees. The quorum for the meeting shall be four.
- b. The chairman of the Trustees shall be the Managing Trustee or any other trustee mutually agreed upon.
- c. The vote of majority present at the meeting prevail and in case of equal division the chairman of the meeting shall have casting vote.
- d. The Board of Trustees shall also be competent to pass any resolution by circulation among them.

The Financial trustee of the Trust shall work for promoting the full accounts for finance of the trust. The accounts of the Trust will be closed on 31st Day of March every year.

The financial year shall be from April to March. The accounts shall be audited by a chartered auditor during every financial year.

The Board of Trustees shall act as a man of ordinary prudence with care and interest in discharging duties diligently and faithfully for the greatest advantage to achieve the object of the trust.

Chas

A member of the Trust can retire or resign from membership informing the Managing Trustee 15 days notice of his desire to retire or resign. The board of trustees together with the Managing Trustee has power to admit or remove any member according to the need of the Trust. Members going against the objectives and regulations of the Trust may be removed by the board of trustees.

The trustees can form any sub committee for special purposes and assign their powers and duties.

The board shall be entitled to make and prescribe from time to time rules and by-laws, regulations for carrying the objectives of the Trust and other matters including the carrying on and adding on the objectives of the Trust and also modify or amend such by-laws and rules and regulations within the framework of the Trust.

It is hereby expressly declared that the trust is absolute and irrevocable.
